Room Rates/Taxes:

Take advantage of the special group rate of \$275.00 per night, single or double occupancy, plus 10% occupancy tax and .65% California tourism assessment fee. This rate does not include a discounted daily, per room resort fee of \$10.00. (The resort fee includes unlimited in-room high speed internet access—wireless and wired—in guest rooms and all public spaces, but not meeting spaces; transportation to resort venues and Trump National Golf Course/Los Verdes Country Club/Shopping/Tennis; trained naturalists for guided tours; full access to fitness center and daily yoga and pilates classes). Optional services, such as baggage handling, room attendant, room delivery, golf bag handling, overnight parking, and other unspecified hotel and guest services will be billed to individual guest rooms. The rate will be offered for three days prior to and after the conference dates **based on hotel availability**.

Reservations must be made by Friday, October 14, 2011. Early reservations are encouraged as there are a limited number of rooms available. AHCA/NCAL will not hold the room block beyond the hotel deadline mentioned above. Reservation requests made after this hotel deadline will be based on availability at the prevailing rate determined by the hotel. Reservations must be accompanied by a first night room deposit or guaranteed with a major credit card. Cancellations must be done seven (7) days prior to the individual arrival date to avoid a penalty fee for the first night's room and tax. Please check for full deposit requirements and cancellation terms at time of booking.

Transportation and Destination Information

Terranea Resort is located 20 miles south of Los Angeles International Airport (LAX, approximately 33 minutes by car); 20 miles north of Long Beach Airport (LGB, approximately 36 minutes by car).
